Pursuant to Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations"), we wish to inform you that Dalmia Cement (Bharat) Limited ('DCBL'), wholly owned subsidiary of the Company, has entered into Share Subscription and Shareholders agreement ('SSSHA') on January 17, 2025, to acquire 26.00% of equity share capital of Solis Urja Energy Private Limited, consisting of 17,50,000 equity shares aggregating to Rs.1,75,00,000/- (Rupees One Crore Seventy five lakhs only), in one or more tranches to source solar power as a captive consumer for a capacity upto 7.0 MWp located in the State of Andhra Pradesh.

The transaction is subject to customary conditions precedents and expected to be completed within 6 Months.
