Pursuant to Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("**Listing Regulations**"), we wish to inform you that Dalmia Cement (Bharat) Limited ("**DCBL**"), wholly owned subsidiary of the Company, have entered into Share Subscription and Shareholders' Agreement ("**SSSA**") and Solar Power Purchase Agreement ("**SPPA**") on June 7, 2024 at 5:05 P.M., to acquire 19.18% of equity share capital of Amplus Kaveri Solar Private Limited, consisting of 1,62,61,200 equity shares aggregating to Rs. 16,26,12,000/- (Rupees Sixteen Crore Twenty-Six Lacs Twelve Thousand only), in one or more tranches to source solar power as a captive consumer for a capacity upto 45.20 MW located in the State of Maharashtra.

The transaction is subject to customary conditions precedents and expected to be completed within a period of 8-9 weeks.

The details as required under Regulation 30 of the Listing Regulations read with SEBI circular No. SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated July 13, 2023 are provided in the Annexure hereto.
